## 2024 FOX CORPORATION POLITICAL ACTIVITIES REPORT

#### **Published February 2025**

Fox Corporation engages in political activity in accordance with the Company's Political Activities Policy, which is supervised by the Nominating and Corporate Governance Committee of the Board of Directors. The Committee reviews and oversees this report, which outlines the Company's engagement efforts in four areas of corporate political activity: the FOX Political Action Committee (FOXPAC); corporate political contributions; lobbying activities and expenditures by FOX; and the Company's participation in trade associations and contributions to non-profit entities.

#### I. FOX POLITICAL ACTION COMMITTEE

FOXPAC is the official federal political action committee for FOX and its subsidiaries. It is registered with the Federal Election Commission. FOXPAC solicits funds from permissible Company employees (except those in news gathering functions) and in turn uses those employee donations to make political contributions to candidates in support of the Company's policy priorities. No corporate treasury funds are used for contributions from FOXPAC. FOXPAC is committed to maintaining a balanced contribution strategy between the two major political parties in making federal political contributions.

In 2024, FOXPAC disbursements totaled \$300,000 evenly divided between Republicans and Democrats. Recipients of FOXPAC support in 2024 were:

#### III. LOBBYING ACTIVITIES

FOX employs government relations experts to advocate on behalf of the Company, its businesses, and its employees. The lobbying activities of FOX Government Relations, in many cases, are required by law to be disclosed at the federal, state, and local level with the respective agency or government entity overseeing lobbying compliance.

In 2024, FOX Government Relations advocated on a wide array of policy issues impacting the Company, including the First Amendment guarantee of a free press, retransmission consent and streaming video policy, advertising and corporate tax policy, children's educational TV programming, spectrum, intellectual property and copyright, media ownership limitations, data privacy, Section 230 of the Communications Decency Act, antitrust enforcement and reform, artificial intelligence, unmanned aerial vehicle issues, and sports betting.

In 2024, FOX's U.S. federal lobbying expenses, as defined by the Lobbying Disclosure Act, totaled \$4,480,000, which includes the relevant portion of employee salaries and travel expenses, and outside expenditures associated with lobbying activity.

FOX employs four executives charged with the Company's government relations activities and who are registered federal lobbyists under the Lobbying Disclosure Act of 1995. Those executives are:

In 2024, FOX engaged outside lobbying services in California, Florida, and New York. Additionally, FOX filed lobbying registration disclosures in New York, NY and Los Angeles, CA. FOX also retained outside lobbying services in Canada. Lobbying disclosures are filed and can be publicly accessed in each jurisdiction by visiting the respective website for each government body.

#### IV. INDUSTRY TRADE ORGANIZATIONS AND NON-PROFIT ORGANIZATIONS

FOX and its business units maintain membership in relevant industry trade organizations to advance the Company's commercial and policy objectives, with an eye toward improving industry dialogue among stakeholders with aligned interests. Fees paid in 2024 to such organizations are for general membership dues and not earmarked for direct or grassroots lobbying. In 2024, membership dues paid by FOX included:

As part of its philanthropy, community engagement, and social responsibility programs, FOX contributes to non-profit entities across the country, with a focus on organizations that assist veterans and first responders, their families, underserved students and the teachers who support them, and disaster relief efforts. The dedication of FOX team members to their local communities is profoundly exhibited by their active participation in the community.

In 2024, FOX supported military veterans, active-duty military, first responders and their families by partnering with U.S.VETS to champion their Make Camo Your Cause campaign, awarding two FOX Pat Tillman Veterans Center scholarships to Cronkite School of Journalism and Media Communications student veterans and presenting grants to caretakers of veterans through the Elizabeth Dole Foundation's Hidden Heroes program. Additionally, FOX committed \$2 million to Tunnel to Towers' Homeless Veteran Program, which will fund housing and supportive services for American veterans experiencing homelessness.

FOX continued to serve as an Annual Disaster Giving Program partner for the American Red Cross while also making an additional donation to the Hurricane Helene & Milton relief efforts. Along with FOX viewer contributions, over \$9,578,487 was raised and donated in aid to support these relief efforts.

The growth of our "FOX For Students" program continued as we renewed our commitment as a Founding Partner of the Roybal Film and Television Production Magnet Program doubling our financial commitment to the school and its mission to build an inclusive pipeline to below-the-line career paths in the entertainment industry through education and real-life experience.

FOX holiday giving programs raised over \$500,000 in November and December of 2024 for non-profit organizations across the country, including the Los Angeles Regional Food Bank, New York Cares, Boys & Girls Clubs of America and the National Alliance on Mental Illness, providing meals, coats, holiday gifts and mental health resources for those in need. FOX supported communities experiencing food insecurity through multiple organizations such as Feeding America, Northwest Harvest and Capital Area Food Bank resulting in over 200,000 meals served.

Additionally, FOX provides invaluable in-kind support through public service announcements and editorial coverage for non-profit organizations such as the Special Olympics, the USO and Stand Up to Jewish Hate, The National Alliance on Mental Illness and more.
